## SEASONAL AGREEMENT 2027

This Seasonal Agreement is between Crazy Acres Campground at Beaver Spring Lake ("CAC") and the Campers ("Seasonals") listed below to lease a campsite for recreational purposes. Your seasonal agreement fee is for 2 adults and your underage children). Extra named adult: \$150 per seasonal pass. If you wish to add someone as part of your seasonal agreement for the full season.

- **SITE:** This Agreement is for the right to use site # \_\_\_\_\_ as a recreational campsite for the self-contained trailer referenced below and (2) automobile(s)
- **TERM:** Seasonal may occupy the site from May 1<sup>st</sup> through October 15<sup>th</sup> for adult the total cost of \$2,900, plus electric for 30 amp site \$3,100 plus electric for 50amp. This seasonal agreement includes:

- (2) adults and their minor-aged children. If you wish to add an additional adult to your seasonal, you must add their names to this agreement and pay \$150 per additional adult.
  - Electric meter on each site; electric to be paid monthly.
  - Full use of campground facilities (boats, games, equipment, pool, bathhouse, showers etc.
  - Only 2 cars are permitted on each site. Additional cars must park in overflow parking upon registering. Do not have your guests park on grass or anywhere other than designated parking areas.
  - Seasonal guests MUST register at the store and get a car pass before heading to your site.
  - If the adult visitor chooses to stay the night, they must register at store and pay overnight fee of \$10 per person (holiday weekends \$10)
- **RENEWAL:** This agreement will be renewed for subsequent seasons only if the site deposit is paid by October 1st and accepted by "CAC". This agreement may not be transferred, assumed by another person(s) or changed orally. ALL previous balances on account MUST BE PAID before OCT 1<sup>st</sup> before renewal is accepted.
  - **RV:** The trailer listed below is the only unit permitted on site. If you change your trailer, you must update the information in our records.

- **SERVICES:** As is feasible, CAC shall provide water, sewer, metered electric services, public restrooms, public grounds throughout the term of this agreement. CAC will not be held responsible for loss of any utilities due to animals, rodents, wildlife, weather or natural occurrences.
- **PETS:** Furry friends are welcome. However, a copy of their current rabies vaccination must be provided to CAC. Pets must be kept on a leash or a lead, AT ALL TIMES. Lead/leash cannot be long enough to reach past your site. Pets are not permitted inside pool area. If these rules are disregarded/broken, CAC WILL ask the seasonal to leave pet at home for safety of others. CAC will not be held responsible or be liable for any injuries, damages, etc. (caused by pet), to Seasonal or any CAC guests and/or their property.
- **USE OF CAMPER:** Seasonal cannot offer use of camper to family/friends without Seasonal being present during the family/friend visits. Camper cannot be lent out to anyone to use when Seasonal is not present.
- **VISITORS:** Seasonal may have up to 4 visitors/guest at a time. If the adult visitor chooses to stay the night, they must register at the store and pay an overnight fee of \$10 per person (on holiday weekends, \$10). If Seasonal desires to have a celebration or event and wishes to have more than 4 people at a time, PRIOR approval must be granted and coordinated with CAC. Additional guests will be \$10 per person for their

visit. **Holiday or premium weekends: adult guests will be charged an entrance fee of \$10 for daily/overnight stay.**

- **INSURANCE:** Seasonal agrees to carry their own comprehensive insurance coverage. CAC will not be held liable for loss, damage or injury from any cause sustained by the Seasonal or the Seasonals family, guests, or their property or belongings. This includes but is not limited to Seasonals trailer, automobile(s), golf cart, other vehicles on site, shed, deck, awning, screen rooms, tents, furniture, ornamental structures, interior furnishings, electronics, camper pantry/refrigerated/frozen items, computer equipment, appliances.
- **GOLF CARTS:** Golf carts are permitted with proof of insurance. CAC is to be listed on the insurance certificate as an additional insured. No other types of vehicles can be used (i.e. quads, gators, UTV's etc.). **All guests must be 16 years old or older to drive any owned or rented golf carts.** There is a MAX of 4 people permitted on rented golf carts. Failure to comply with this rule will be cause for cancellation of golf cart privilege at CAC for Seasonal. Golf carts must abide by the 5 MPH rule throughout the campground. If at any time, golf carts are being used in a manner that CAC may deem unsafe, Seasonal will lose the privilege to bring a golf cart to the campground.
- **RULES/REGULATIONS:** This Agreement is subject to the CAC "Campground Rules and Policies" and "Seasonal Information and Rules" and subsequent updates or revisions. By signing this Agreement, The Seasonal agrees they have received a copy of this Agreement and all other information as mentioned in this Agreement. Seasonal acknowledges they have received a copy of the "Campground Rules and Regulations" and agree that Seasonals and their guests will abide by them.

#### **ADDITIONAL INFORMATION – SITE DETAILS AND DISCOUNTS OFFERED**

- Sites are open wide and deep with space for one RV and up to 2 Motor Vehicles.
- Picnic table and fire-ring at each site.
- Dumpsters for trash and recycling located at the beginning of the campground. Seasonal responsible for their own trash disposal from their site to dumpsters.
- Extra named adult: \$150 per seasonal pass. If you wish to add someone as part of your seasonal agreement for the full season.
- Decks and sheds are permitted with prior approval of materials and design.
- Seasonals receive a 10% discount on propane
- 10% discount for Seasonals **FAMILY** members ONLY, who rent an RV, Cabin or site at CAC **(Can be used once per month) (Discount not offered on holidays)**
- Pets welcomed. Tinkle Trail, nature walks and doo-doo drop cans available. **Dogs MUST be kept on leashes AT ALL TIMES or a lead at your campsite, but not to be left unattended. If this rule is broken, we will ask that the pet be left at home. A copy of rabies vaccine must be presented at time of check-in.**
- Large, open field areas available for playing, walking, relaxing, viewing.
- Hiking trail leading to creek

- Seasonals must maintain their site. Site cannot have broken down camping equipment, mattresses, broken or dilapidated awnings, BBQ's, overgrown grass/weeds, garbage, extra trailers etc. Sites are expected to be kept neat, safe and maintained. There must be clear access to the meter for CAC to read once a month.
- Children under the age of 18 must be at their campsite no later than 10pm unless accompanied by parents.

## **SPEED LIMIT 5 MPH THROUGHOUT THE CAMPGROUND**

**WINTER STORAGE:** CAC offers storage for our Seasonals for RV's, sheds, boats, decks and steps. RV onsite storage is \$30 per month; \$210 for seven months. **This will be due and payable with first payment/deposit (October 1<sup>st</sup>)**

### **PAYMENT SCHEDULE:**

- Payments can be made via **CASH OR CHECK (If using a credit card, 3% will be added)**
  1. **1<sup>st</sup> Payment: October 1<sup>ST</sup> - \$900 non-refundable site deposit; (plus storage fee of \$210) only if you are leaving your camper on site for the off season **\*\*note: if agreement and down payment are not received by October 1<sup>st</sup>, your seasonal spot will not be guaranteed\*\*****
  2. **2<sup>nd</sup> Payment: February 1<sup>ST</sup> - \$600**
  3. **3<sup>rd</sup> Payment: March 1<sup>ST</sup> - \$600**
  4. **4<sup>th</sup> Payment: April 1<sup>ST</sup> - \$800 (\$1000 for 50 amp sites)**

**CANCELLATION:** If at any time, Seasonal wishes to cancel their seasonal contract early:

#### **1. SITE DEPOSIT IS NON-REFUNDABLE**

2. 2nd payment is non-refundable if cancelled by Seasonal after April 15<sup>th</sup>.  
Credit issued for camping.
3. If cancelled, storage will be due for sheds, boats, etc.
4. Seasonal license and site are non-transferable.
5. If RV is sold to a party wishing to become CAC Seasonal. The purchaser must fill out a seasonal wait list application until a spot becomes available. A \$150 processing fee will be due to Crazy Acres Campground payable by new seasonals/owners.

### **TERMINATION:**

1. CAC may terminate this Agreement for just cause with NO refunds.

Reasons to terminate may be as follows or as amended by CAC:

- ✚ Failure to pay rent by due date
- ✚ Failure to pay any fees for services rendered by CAC in a timely manner
- ✚ Failure to pay electric bill within (1) month of billed date
- ✚ Non-compliance of CAC Rules and Regulations
- ✚ Non-compliance of Seasonals Rules and Regulations

- ✚ Misconduct by Seasonal, pets, family or visitors/guests of Seasonal, which constitutes a substantial annoyance, nuisance, danger to other occupants and their property or CAC property
- ✚ Misuse of CAC property (i.e. washer/dryer, game room equipment, boats, playground equipment rental equipment, golf carts, etc.)

**THIS AGREEMENT IS NON-TRANSFERRABLE**
